

Harbor Fees

BOAT LAUNCH RAMP:

Ramp use (prior notice)	\$5.50/use (Two free with annual moorage)
Season Ticket: May thru September or October thru April	\$27.50 per period (Season)
Ramp use without prior notice or arrangements	\$10.00

USE OF FISH CLEANING TABLE:

Boats paying stall rental	Free
Boats or entities not paying stall rental	\$11.00 per use
Commercial charter boats	\$55.00 annual
Boats not paying stall rental can pay an annual fee	\$82.50 annual

TOUR BOAT LANDING SERVICE:

\$13.20 per day

PORT FEE:

A fee of \$1.00 per disembarking passenger ages 12 and over will be assessed on all commercial passenger vessels carrying passengers for transport from another port into the Seldovia small boat harbor.

Footnote: This includes any tour boats departing any other port discharging passengers into the seldovia small boat harbor regardless of other non-sport fishing activities en-route. This fee excludes charter fishing vessels paying day use fee in the harbor.

FRESH WATER FEE:

Commercial charter, tour,	\$5.50 per day or
Ferry vessel, wash down boats	\$32.00 per month or
	\$55.00 annually

ANNUAL MOORAGE

prepaid annually	\$17.95/ft or stall length, whichever is greater.
monthly installments	\$1.85/ft or stall length, whichever is greater.

Note: If moorage paid in monthly installment is the chosen method of payment, it must be understood by the boat owner that the term of the agreement is for 12 months, otherwise TRANSIENT rates shall apply.

Note: The open skiff area and the large boat float area will be charged on vessel length only.

Note: Vessels desiring annual moorage will be given first choice of available harbor stalls.

Note: All vessels over 100 feet in length must pay at the monthly rate and as additional surcharge of \$10.00 per foot per month will be assessed on that portion of a vessel over 100 feet moored at Seldovia Boat Harbor

TRANSIENT MOORAGE

per day	\$0.94/ft or stall length, whichever is greater.
per month:	\$5.25/ft or stall length, whichever is greater
per six months:	\$13.86/ft or stall length, whichever is greater
float planes (first come, first served, space available basis):	\$20.90 per day
Fourth of July moorage (day):	\$10.00 (minimum fee for the Fourth of July)

Note: A discount of \$0.22 per foot is given for moorage paid in advance on the daily rate and a discount of \$0.88 per foot is given for moorage paid in advance on the monthly rate

Note: All vessels mooring in the seldovia small boat harbor for any period of time not paying annual, monthly, or overnight moorage shall be charged a \$5.00 day use fee.

GRIDIRON FEES (Based on each 12 hours, or portion thereof)

less than 32 feet	\$16.50
more than 32 feet but less than 60 feet	\$37.50
greater than or equal to 60 feet	\$52.25

ELECTRICAL POWER FEES

A. Stall Rates (long term users)

110V	\$15.80/mo +electrical usage (see note) + tax
220V	\$15.90/mo + electrical usage (see note) + tax
208V	\$16.00/mo + electrical usage (see note) + tax

B. Connect/reconnect charge (each time) \$15.00

C. Electrical deposit (refundable) \$50.00

D. Daily rate \$13.00

Note: the electric kilowatt hour charged to harbor and boat storage customers shall be at the rate equal to the total cost per kilowatt hour paid by the City of Seldovia to HEA at the end of the preceding calendar quarter.

PUMPING AND SHOVELING OF VESSELS actual cost + 20% (\$50.00 minimum)

Note: This is a labor only fee and any pump rental (if necessary) shall be extra (see City Equipment Fees for rates)
