## CITY OF SELDOVIA

### ORDINANCE 18-10

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SELDOVIA, ALASKA, AMENDING TITLE 2.04.030 MEETINGS—PUBLIC TO PRESENTATION DOCUMENTATION PRIOR NOTICE SHALL BE SUBMITTED TUESDAY INSTEAD OF THURSDAY AND 2.04.040 MEETINGS-- PROCEDURES TO REGULAR MEETINGS SHALL BE HELD MONDAY AT SIX PM INSTEAD OF WEDNESDAY AT SEVEN-THIRTY PM**

**WHEREAS**, it is in the best interest of the City of Seldovia to hold regular meetings at a time that best suits the public and the City Council of Seldovia; and

**WHEREAS**, holding regular meetings on Monday at an early start time of 6:00pm will better accommodate the public, the City Council of Seldovia and the City staff.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SELDOVIA:**

**SECTION 1. CLASSIFICATION.** This ordinance is permanent in nature and shall become a part of the Municipal Code of the City of Seldovia.

**SECTION 2. EFFECTIVE DATE.** This ordinance becomes effective July 1<sup>st</sup>, 2018.

**SECTION 3. AMENDING TITLE 2.04.030 MEETINGS –PUBLIC AND 2.04.040 MEETINGS— PROCEDURES BY REMOVING LANGUAGE IN STRIKEOUT AND ADDING LANGUAGE IN HIGHLIGHT TO READ AS FOLLOWS:**

**2.04.030 Meetings -- Public.** All meetings of the Council and of committees, commissions, boards or agencies created or authorized by the Council or by this code, supported in whole or in part by public funds, or entrusted with expending public funds, shall be open to the public except as otherwise provided in Alaska Statutes 44.62.310. (Ord. 87-4 Sec. 1, 1987)

A. Public Presentation Prior Notice Process: All public presentations and documentation of shall be submitted to the City Manager by 5 pm the ~~Thursday~~ **Tuesday** preceding a Council meeting. Presentations and documents submitted after the above deadline will be held until the next scheduled meeting. (Ord. 17-01)

B. Prohibiting Public Call in's to Council Meetings. The public is prohibited to attend meetings via phone, teleconference or any electronic media conferencing system. This provision does not apply to the Mayor, Council Members, or those who represent the City of Seldovia; for example but not limited to; City Manager, City attorneys or City staff. (Ord. 16-14)

**2.04.040 Meetings -- Procedures.** A. The regular meetings of the City Council will be held in the Seldovia City Library Building on the second and fourth ~~Wednesday~~ **Monday** of each month, at the hours of ~~seven-thirty~~ **six (6)** p.m. If a majority of the members are given at least 24 hours oral or written notice and reasonable efforts are made to notify all members, a special meeting of the City Council may be held at the call of the Mayor or at least one-third of the members. A special meeting may be conducted with less than 24 hours' notice if all members are present, or if absent members have waived in writing the required notice. Waiver of notice can be made before or after the special meeting is held. A waiver of notice shall be made a part of the journal of the meeting. (Ord. 87-4 Sec. 1, 1987)
