### ORDINANCE 18-06

#### AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SELDOVIA, ALASKA, AMENDING TITLE 8 HEALTH AND SAFETY SECTION 8.12.120 DUMPING ON PUBLIC PROPERTY AND TITLE 1 GENERAL PROVISIONS SECTION 1.08.040 CODE SECTION 8.12.120 TO INCLUDE PRIVATE PROPERTY

**SECTION 1. CLASSIFICATION.** This ordinance is permanent in nature and shall become a part of the Municipal Code of the City of Seldovia.

**SECTION 2.** Title 8.12.120 is amended by deleting the language in ~~bold-strikeout~~ and adding the language in **bold highlighted** to read as follows:

**8.12.120 ~~Dumping~~ **Depositing** on public **or private** property.** It is unlawful for any person to dump, throw, **deposit or discard** ~~or place~~, on any public **or private** property or right of-way, or allow to remain on any premises occupied, owned or subject to the control of such person, any refuse, including garbage, rubbish or ashes, unless the same shall be kept in containers of a type suitable to the refuse in question and unless the disposal of such refuse has been provided for **established in section 8.12.070 of this code.** (Ord. 96-16)

**SECTION 2.** Title 1.08.040 is amended by adding the language in **bold highlighted** to read as follows:

8.12.120 | Unlawful dumping on public or private property/right of way



**SECTION 3. EFFECTIVE DATE.** This ordinance becomes effective upon its adoption by the City Council.


